VOLUNTARY RECALL: Sterling Rope 8mm Sewn Cord Products

As part of our ongoing quality control efforts, Sterling Rope Co. Inc. regularly tests our products to ensure they meet or exceed our performance standards. We recently tested some of our 8mm sewn cord products and found that samples from certain lot numbers were breaking at a lower strength than our published MBS values.

Statement of Associated Risk: While we feel the products affected are still safe when used properly by trained personnel at their rated safe working load (SWL), we are offering a voluntary recall of this product for exchange or replacement with a Sterling Rope item of equal or lesser value.

What should a Customer do? Customers who purchased these types of products should check to see if their lot numbers are among those included in the voluntary recall (see instructions below). In an abundance of caution, we recommend users who have products affected by this recall retire them from use immediately and return them to Sterling Rope at their earliest convenience.

How to Check a Product's Lot Number

Sterling Rope products display the production lot number in two places. The lot number is printed on the barcode label affixed to our Care, Use and Retirement document (see photo A). The lot number is also printed on the shrink tube label on the sewn portion of the prusik (see photo B).

How to Order Replacement Inventory of a Recalled Product

Dealers who anticipate replacing recalled products for their customers, have TWO OPTIONS to obtain relief:

- Sterling will ship replacement inventory to dealers with Free Freight and 60-day terms to ensure product is in-stock for rapid exchange. Credit will be applied to your account when returned product is received at Sterling Rope through the RA process.
- Sterling will drop ship replacement product to your customers at no charge. Once we have issued a call tag to your customer, we will send the replacement product. There is no need for you to invoice your customer for the replacements.

How to Return or Exchange a Recalled Product

FOR DEALERS:

Products that are in stock or returned by your customer:

Contact Sterling Rope directly and obtain a Return Authorization Number (RA#) and a call tag or shipping label to return the product to us at no charge. We ask that you collect the products in one box and ship the items back to us in a single shipment, once you have reached out to any affected customers.

Products that were shipped to your customer:

Provide us with your customer's name and contact information and we will coordinate the return. We will need to know the quantity of products sold and the shipping address for replacement.

FOR CUSTOMERS:

Products ordered in the USA:

Customers have two options for returning or exchanging these recalled products:

- Return the product to the Authorized Sterling Dealer where you made the purchase. They will accept the product and provide you a replacement of equal or lesser value, or place an order for you if the item is not currently in stock
- Contact Sterling Rope directly and obtain a Return Authorization Number (RA#). You can contact us by email at returns@sterlingrope.com or via phone at 800-788-7673 and we will send you a call tag to ship the product back to us at no charge. Once we receive the recalled product, we will ship you a replacement of equal or lesser value at our expense.

Products ordered outside the USA:

Customers can contact Sterling Rope at 207-282-2550 or <u>returns@sterlingrope.com</u> and we will coordinate the product exchange with the distributor in your country.
